

**ORDINANCE 2017-02**

**AN ORDINANCE OF THE CITY OF LAKE WALES, POLK COUNTY, FLORIDA, AMENDING THE LAKE WALES CODE OF ORDINANCES, BY AMENDING CHAPTER 2, ADMINISTRATION, ARTICLE II, BOARDS, COMMITTEES, AND COMMISSIONS BY ELIMINATING DIVISION 6, OPEN HOUSE BOARD; DIVISION 8, PARKS AND COMMUNITY APPEARANCE ADVISORY BOARD; DIVISION 9, PARKING AUTHORITY; DIVISION 11, LAKES ADVISORY COMMISSION; DIVISION 12, HISTORIC PRESERVATION BOARD; DIVISION 13, FIRE AND BUILDING CODE ADMINISTRATION BOARD; DIVISION 14, ENTERPRISE ZONE DEVELOPMENT AGENCY; DIVISION 15, BICYCLE/PEDESTRIAN ADVISORY COMMISSION; AMENDING CHAPTER 2, ADMINISTRATION, ARTICLE V, FINANCIAL ADMINISTRATION, DIVISION 1, INVESTMENT OF PUBLIC FUNDS, BY ELIMINATING SECTION 2-502, DELEGATION OF AUTHORITY, ESTABLISHMENT OF INVESTMENT COMMITTEE; AMENDING CHAPTER 2, ADMINISTRATION, ARTICLE VII, PROGRAM ADMINISTRATION, BY ELIMINATING DIVISION 1, AWARE PROGRAM; AND AMENDING CHAPTER 15, MISCELLANEOUS OFFENSES BY ELIMINATING SECTION 15-10, DRUG AND PROSTITUTION-RELATED NUISANCE ABATEMENT; AND PROVIDING FOR AN EFFECTIVE DATE.**

**BE IT ENACTED**, by the City Commission of the City of Lake Wales, Polk County, Florida,

- SECTION 1.** Chapter 2, Article II, Division 6, Open Housing Board, of the Lake Wales Code of Ordinances is hereby deleted from the said Code of Ordinances by repeal of Code 1962 §§ 9½-19, 91/2-20 and 9-1/2-21.
- SECTION 2.** Chapter 2, Article II, Division 8, Parks and Community Appearance Advisory Board, of the Lake Wales Code of Ordinances is hereby deleted from the said Code of Ordinances by repeal of Ordinance 2007-10, § 1.
- SECTION 3.** Chapter 2, Article II, Division 9, Parking Authority, of the Lake Wales Code of Ordinances is hereby deleted from the said Code of Ordinances by repeal of Code 1962, §§ 2-146 and 2-147.
- SECTION 4.** Chapter 2, Article II, Division 11, Lakes Advisory Commission, of the Lake Wales Code of Ordinances is hereby deleted from the said Code of Ordinances by repeal of Ordinance 2003-23, § 1.
- SECTION 5.** Chapter 2, Article II, Division 12, Historic Preservation Board, of the Lake Wales Code of Ordinances is hereby deleted from the said Code of Ordinances by repeal of Ordinance 2002-18, § 1, as amended by Ordinances 2003-06 and 2006-47.
- SECTION 6.** Chapter 2, Article II, Division 13, Fire and Building Code Administration Board, of the Lake Wales Code of Ordinances is

hereby deleted from the said Code of Ordinances by repeal of Ordinance 2003-18, § 1.

**SECTION 7.** Chapter 2, Article II, Division 14, Enterprise Zone Development Agency, of the Lake Wales Code of Ordinances is hereby deleted from the said Code of Ordinances by repeal of Ordinance 2004-05, § 1.

**SECTION 8.** Chapter 2, Article II, Division 15, Bicycle/Pedestrian Advisory Commission, of the Lake Wales Code of Ordinances is hereby deleted from the said Code of Ordinances by repeal of Ordinances 2005-26, § 1 and 2005-45, § 1.

**SECTION 9.** Chapter 2, Article V, Division 1, Investment of Public Funds, Section 2-502, Delegation of Authority; Establishment of Investment Committee, of the Lake Wales Code of Ordinances is hereby deleted from the said Code of Ordinances by repeal of Sec. 2-502 of Ordinance 95-44, § 1,


**SECTION 10.** Chapter 2, Article VII, Division 1, Aware Program, of the Lake Wales Code of Ordinances is hereby deleted from the said Code of Ordinances by repeal of Ordinances 97-03, § 1, 98-17, § 1, and 2006-47, § 1.

**SECTION 11.** Chapter 15, Miscellaneous Offenses, Section 15-10, Drug and Prostitution-Related Nuisance Abatement, of the Lake Wales Code of Ordinances is hereby deleted from the said Code of Ordinances by repeal of Sec. 15-10 of Ordinance 2007-27, §1,

**SECTION 12.** If any clause, section or provision of this ordinance shall be declared unconstitutional or invalid for any reason or cause, the remaining portion of said ordinance shall be in full force and effect and be valid as if such invalid portion thereof had not been incorporated herein.

**SECTION 13.** This ordinance shall become effective immediately upon its passage by the City Commission.
