CITY MANAGER RESIGNATION

City Attorney Chuck Galloway said Ms. Leary offered to give her resignation in exchange for the same consideration she would receive if she were terminated.

Mr. Galloway gave the following options:

- Ms. Leary Continues to serve as City Manager
- The Commission accepts Ms. Leary's resignation

Mr. Galloway said that acceptance of the City Manager's resignation, was a much better solution to what appeared to him to be a problem for the City. Acceptance would not involve the Charter or the necessity of a Resolution to Terminate, including all ramifications associated with that.

Mr. Galloway said he had spoken with Ms. Leary the day before and she had asked that the Commission consider giving her two months of health insurance coverage. Ms. Ecklund said Ms. Leary is eligible for the same COBRA insurance as other city employees though she will have to pay for the two months if she wants the coverage, just as they do.

PUBLIC COMMENT

There were no comments from the public.

Commissioner Howell made a motion to accept the resignation of City Manager Terry Leary with the stipulation that she will pay her two months of insurance. The motion was seconded by Commissioner Lutton.

INTERIM CITY MANAGER

Mr. Galloway said the Commission needed to decide who will serve as the interim City Manager as the Resolution stating who will act as City Manager in Ms. Leary's absence, which is Dorothy Ecklund, no longer applies. He said, in his opinion, if it is the Commission's intent for Ms. Ecklund to continue to serve in that capacity, she should be named to serve as the Interim City Manager, giving her all of the powers that a city manager has to conduct the administrative affairs of the City.

Ms. Ecklund was asked if she was willing to serve as the Interim City Manager and if she thought she would be able to also perform her duties as Finance Director. She advised she was willing to serve and could perform all to the necessary duties.

As Ms. Ecklund would be performing the city managers duties plus her own department duties there was a discussion about her compensation. Human Resource Director Sandra Davis and the City Attorney will work on a compensation package to be presented to the Commission.

Commissioner Howell made a motion to accept Finance Director Dorothy Ecklund as the Interim City Manager. The motion was seconded by Commissioner Thornhill.
