The City Clerk asked for a motion to accept the absent ballots as reviewed by her and direct Supervisor of Elections staff to begin processing them. Commissioner Howell made the first motion and Commissioner Thornhill seconded the motion.

REVIEW 24 ABSENTEE BALLOTS AS RECOMMENDED BY CITY CLERK

The City Clerk reported that 16 of the 24 absentee ballots mailed were undelivered and the other 8 needed to be reviewed by the Canvassing Board. Seven of the 8 absent ballots is where husband and wife signed each other's ballot and the other one the signature needed to be reviewed.

Two more absentee ballots were received.

The Canvassing Board reviewed the 10 absent ballots and 6 were accepted and 4 were not. The City Clerk said the updated total valid absentee ballots were 1,188.

The City Clerk asked for a motion to direct Supervisor of Elections staff to begin processing the 6 valid absentee ballots reviewed by the Canvassing Board. Commissioner Thornhill made the first motion and Commissioner Wojcik seconded the motion.
