SYNOPSIS

The City Commission will consider accepting a grant agreement from the Federal Aviation Administration for the construction phase for Runway 6-24 Rehabilitation at the Lake Wales Municipal Airport in the amount of \$1,160,193.00.

RECOMMENDATION

Staff recommends that the City Commission approve the following action:

- 1. Accept the grant from the Federal Aviation Administration (FAA) for the construction phase for Runway 6-24 Rehabilitation at the Lake Wales Municipal Airport in the amount of \$1,160,193.00.
- 2. Authorize the Mayor to accept the grant offer on behalf of the City.

BACKGROUND

On June 2016, the City adopted Resolution 2016-15 authorizing an agreement with the Florida Department of Transportation (FDOT) to provide funding to rehabilitate and extend Runway 6-24.

On September 8, 2016, the City received notification of an allocation of \$1,160,193.00 from the Federal Aviation Administration (FAA). This grant is specific for rehabilitation of Runway 6-24 at the Lake Wales Municipal Airport.

FISCAL IMPACT

Funding is as follows:

FAA (90%) \$1,160,193.00

City (5%) \$64,455.00 (funds will be available in the 16/17 City budget)

State (5%) \$64,455.00

Project total: \$1,289,103.00

OTHER OPTION

The City has already accepted funding from the FAA and FDOT for prior phases of this project.
