Whether the appointment would be until the next election or for the full term is a question for the City Attorney. Commissioner Howell explained that she was looking for someone to run. She is willing to serve. Deputy Mayor Robin Gibson said that this could be the opportunity to get someone good without this person having to run. He said that Commissioner Howell should have input on who would fill the vacancy. Mayor Fultz said he will hold his opinions for now. Commissioner Howell said we need someone who wants to be for all of Lake Wales. Commissioner Curtis Gibson asked Commissioner Howell if she was still willing to do it. Mayor Fultz said we need to think on this. Deputy Mayor Gibson said we should do this before she leaves.
