A RESOLUTION OF THE CITY OF LAKE WALES, FLORIDA, MAKING FINDINGS CONCERNING PREVIOUSLY APPROVED PLATS OF REAL PROPERTY LYING WITHIN THE CORPORATE LIMITS OF THE CITY OF LAKE WALES; FORMALLY ACCEPTING DEDICATIONS TO THE PUBLIC SET FORTH WITHIN THE SAID PLATS; PROVIDING FOR THE ACCEPTANCE ON BEHALF OF THE PUBLIC OF FUTURE DEDICATIONS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Lake Wales (the "City") has since its incorporation by action of its City Commission approved the Plats of land within the corporate limits of the City; and

WHEREAS, such Plats generally include lands which are dedicated to the public such as roads, streets, alleys, parks, easements, and other portions of the plated property for public use; and

WHEREAS, the approval of such plats does not legally constitute acceptance of the lands dedicated to the public; and

WHEREAS, the acceptance of dedicated lands may be made by formal Resolution by the governing body, and the second second

WHEREAS, the City desires to remove any doubt as to the acceptance on behalf of the public of all lands dedicated to the public in the Plats previously approved by the City or lying within the corporate limits of the City.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Lake Wales, Florida:

SECTION 1. FINDINGS. Numerous Plats have been approved by the City of Lake Wales during the course of its corporate existence and the Plats of land lying within the corporate limits of the City provide for dedication of certain lands to the public. A list of all Plats lying within the corporate limits of the City of Lake Wales is attached hereto and made a part hereof as Exhibit "A".

SECTION 2. ACCEPTANCE OF DEDICATIONS TO THE PUBLIC. The dedications to the public found in any of the Plats shown in the attached list are hereby accepted by the City of Lake Wales on behalf of its citizenry.



SECTION 3. ACCEPTANCE OF FUTURE DEDICATIONS TO THE PUBLIC. An acceptance of all public dedications found in future Plats to be approved by the City of Lake Wales shall be accomplished by the contemporaneous adoption of a Resolution accepting the public dedications set forth on the Plat on behalf of the public at the time of approval of the proposed Plat.

SECTION 4. EFFECTIVE DATE. This Resolution shall take effect immediately upon adoption.


