TRANSPORTATION POST PROJECT MAINTENANCE AGREEMENT BETWEEN FLORIDA DEPARTMENT OF TRANSPORTATION AND CITY OF LAKE WALES

This is an Agreement, by and between the STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION, hereinafter referred to as the "DEPARTMENT," and the CITY OF LAKE WALES, hereinafter referred to as "LOCAL AGENCY" for the maintenance of post-project transportation enhancements described below.

WITNESSETH

- 1. WHEREAS, pursuant to the American Recovery and Reinvestment Act of 2009, the DEPARTMENT is authorized to undertake a project within the LOCAL GOVERNMENT geographical limits; and
- 2. WHEREAS, said project is identified and known to the parties as Financial Project # 426639 1 52/62 01, which will benefit the LOCAL AGENCY; and
- 3. WHEREAS, in accordance with Title 23, U.S. Code, Section 116 and Federal Highway Administration regulations issued pursuant thereto, there must be an agreement from the LOCAL GOVERNMENT to maintain the project; and
- WHEREAS, the LOCAL GOVERNMENT by Resolution No. 2009-0 dated <u>Jone J., 2009</u>, a copy of which is attached hereto and made a part hereof, has consented to and approved the Agreement and has authorized its Mayor or designee to execute said Agreement.

NOW, THEREFORE, in consideration of the premises, the parties agree as follows:

- 1. The DEPARTMENT has undertaken the project and obtained approval for federal participation for Lake Wales Trail from SR 17 to 4th Street.
- It is understood and agreed by the parties that upon completion of the project, the LOCAL AGENCY shall be responsible, at its costs, for maintenance of said project in accordance with the following federally accepted state standards: (a) Manual of Uniform Minimum Standards for Design, Construction and Maintenance for Streets and Highways (2005), as amended; (b) FDOT Procedures 850-065-001 and 850-065-002, as amended.
- 3. This document incorporates and includes all prior negotiations, correspondence, conversations, agreements or understandings applicable to the matters contained herein and the parties agree that there are no commitments, agreements or understanding concerning the subject matter of this Agreement that are not contained in this document. Accordingly, it is agreed that no deviation from the terms hereof shall be predicated upon any prior representation or agreements whether oral or written.
