WHEREAS, the City Commission has expressed an interest in the provision of affordable housing to the citizens of Lake Wales; and

WHEREAS, the City took title of the parcel on C Street, Parcel ID #272935-879000-002190 as shown on Attachment "A," through a reverter clause established in a 2006 Deed to the Green & Gold Foundation; and

WHEREAS, no municipal use has been identified for the property; and

WHEREAS, the City wishes to reduce maintenance responsibilities for publicly-owned property; and

WHEREAS, the City wishes to expand affordable housing opportunities for citizens; and

WHEREAS, Habitat for Humanity of East Polk County, Inc. has expressed an interest in building a house on the property;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAKE WALES, POLK COUNTY, FLORIDA as follows:

- 1. The City Commission approves the conveyance of said lot to Habitat for Humanity East Polk County, Incorporated.
- 2. The City Commission authorizes the City Attorney to prepare appropriate legal documents to execute conveyance.
- 3. The City Commission authorizes the Mayor to sign documents to execute the conveyance.


