RESOLUTION NO. 2015-17

A RESOLUTION CLOSING, VACATING, RENOUNCING AND DISCLAIMING ANY RIGHTS OF THE CITY AND THE PUBLIC IN AND TO A PORTION OF WESTEND BLVD.

WHEREAS, CFHC We Care, Inc., a Florida not-for-profit corporation, is the contract vendee for certain real property located at the corner of Central Avenue and Sharp Street on which the former Lake Wales Adult Day Care facility is located; and

WHEREAS, a title examination and survey has revealed that an easement granted to the City encroaches onto a portion of the subject real property; and

WHEREAS, it is in the public interest to assist in this title curative effort by vacating a portion of the easement for the purposes of facilitating the provision of additional health care services within the City of Lake Wales; and

WHEREAS, Notice of Hearing has been duly published and the City Commission has received input from all interested parties as to the advisability of taking this action and has determined that the proposed action will not interfere with any present road system and will not deprive any person of a reasonable means of ingress and egress to his or her premises.

NOW THEREFORE, BE IT RESOLVED that the City of Lake Wales, by and through its City Commission, does hereby renounce and disclaim any interest of the City of Lake Wales and the public in and to that portion of a certain easement for Westend Blvd., in Lake Wales, Polk County, Florida, more particularly described in the Attached Exhibit "A" and depicted in the attached Exhibit "B".


