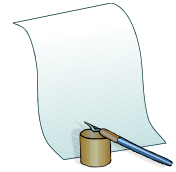

Proposed TRIM Calendar FY 15'16

June 1st

- 1st Estimates of property values provided to the City from Property Appraiser's Office

July 1st

- Certification date for Preliminary Tax Roll (TRIM Day 1)

July 21st Commission Meeting

- Set Interim Millage Rate
- Date, Time, Place of 1st Budget Hearing
(Deadline to Property Appraiser Office is August 4th)

Budget Hearing:

- September 3rd (Tentative Hearing).
 - September 12th for required newspaper advertising.
 - September 15th (Final Budget Hearing).
- 1) TRIM requires that the City select meeting dates that do not conflict with the Board of County Commissioners or the School Board. For FY 2015'16, School Board is **September 8th** and the Board of County Commission is **September 14th** and **September 21st**.
 - 2) TRIM requirements prevent the "Tentative Hearing" from being held before September 3rd, but it must be held no later than September 18th.
 - 3) TRIM requires the "Final Budget Hearing" to be held within 15 days of the "Tentative Hearing".
 - 4) TRIM requires that the "Final Budget Hearing" must be held within 2 – 5 days after the required public newspaper advertisement.
