- 1) TRIM requires that the City select meeting dates that do not conflict with the Board of County Commissioners or the School Board. For FY 2015'16, School Board is **September 8**th and the Board of County Commission is **September 14**th and **September 21**st.
- 2) TRIM requirements prevent the "Tentative Hearing" from being held before September 3rd, but it must be held no later than September 18th.
- 3) TRIM requires the "Final Budget Hearing" to be held within 15 days of the "Tentative Hearing".
- 4) TRIM requires that the "Final Budget Hearing" must be held within 2-5 days after the required public newspaper advertisement.
