## **Budget Hearing:**

- September 3<sup>rd</sup> (Tentative Hearing).

- September 15<sup>th</sup> (Final Budget Hearing).
- TRIM requires that the City select meeting dates that do not conflict with the Board of County Commissioners or the School Board. For FY 2015'16, School Board is September 8<sup>th</sup> and the Board of County Commission is September 14<sup>th</sup> and September 21<sup>st</sup>.
- 2) TRIM requirements prevent the "Tentative Hearing" from being held before September 3<sup>rd</sup>, but it must be held no later than September 18<sup>th</sup>.
- 3) TRIM requires the "Final Budget Hearing" to be held within 15 days of the "Tentative Hearing".
- 4) TRIM requires that the "Final Budget Hearing" must be held within 2 5 days after the required public newspaper advertisement.
